### Dealership Requirements

1. *As a Paramount Windows & Doors Authorized Dealer we are obligated to represent Paramount Windows & Doors in a professional manner, at all times displaying a working knowledge of the product line. Violation of this can result in loss of dealership.*
2. *As a Paramount Windows & Doors Dealer we will display a self-standing or full-size showroom display. Self-standing and full-size showroom displays are rentals only. (Paramount Windows & Doors own the self-standing and full-size showroom displays). We further agree to keep these displays in good condition and up to date. Paramount Windows & Doors reserves the right to remove rented displays if Paramount Windows & Doors is forced to remove the "Active" dealership status.*
3. *As a Paramount Windows & Doors dealer we understand that all bids require a re-bid after thirty days.*
4. *As a Paramount Windows & Doors dealer we accept full responsibility for material loss or handling damage on goods received unless the office is notified in writing within two working days of product reception, or noted on the shipping invoice.*
5. *As a Paramount Windows & Doors dealer, we agree to service all products purchased by our company. We agree that the Paramount Windows & Doors sales representative determines this level of expected service.*
6. *As a Paramount Windows & Doors authorized dealer we understand that all Paramount Windows & Doors products which are installed contrary to the published installation instructions do not carry a warranty. We understand that Paramount Windows & Doors recommends only licensed glazing contractors, in good standing with the contractor's board to install its products.*
7. *As a Paramount Windows & Doors Authorized Dealer we understand that a minimum of \$3,000.00 annual sales is required in order to maintain "Active" status. Once "Active" status is lost, we understand we must be re-qualified. (Contact the office for a copy of "Qualifications Procedures for Prospective Paramount Windows & Doors Dealers".)*
8. *As a Paramount Windows & Doors Authorized Dealer, if we do not accept a scheduled delivery, we will receive the delivery the following working day. Jobsite delivery is available upon request at a charge of \$125.00-\$350.00, depending on the location.*
9. *As a Paramount Windows & Doors Authorized Dealer, we will provide Paramount Windows & Doors with a legible quote sheet when requesting a bid. In addition, we hold Paramount Windows & Doors responsible only for the information specifically stated on the quotation, regardless of specifications.*
10. *As a Paramount Windows & Doors Authorized Dealer, we understand that there is a point at which an order cannot be canceled or changed. In such cases, we accept full responsibility for the charges. Up to the point of no return we will be charged a labor and materials fee for each change request made to an order (no charge if the order has not been processed and entered in the system).*
11. *As a Paramount Windows & Doors Authorized Dealer, we have received Paramount Windows & Doors "Terms and Conditions" and both documents regarding "Warranty".*
